

The meeting of Cavendish Parish Council took place on Wednesday 10th September 2025. In the Cavendish Memorial Hall at 7.30pm.

1. Acceptance of apologies for absence.

4. Public Session (20 minutes)

Emergency Road Closure. Two members of the public expressed concern on how the emergency road closure outside the Colombines, Melford Road was handled. Signage was inadequate. Road closure notifications were not submitted to Suffolk County Council in a timely manner resulting in an emergency ambulance being unaware of the road closure and trying to drive through. The resulting repair to enable the road to be reopened took too long. County Councillor Bobby Bennett confirmed that it was unacceptable and that Anglian Water failed in their duty resulting in a formal complaint from Suffolk County Council.

Allotment. A member of the public submitted a request to move the Allotment Bins and create hardstanding. It was agreed that this would be investigated and added to the agenda for the next meeting. It was reported that one of the allotment plots was in an unkempt condition. Nick Vosper to investigate and contact the allotment holder if required.
